On the basis of Article 35 of the Rulebook on the manner and procedure of announcing and conducting a public tender for the conceptual architectural design ("Official Gazette of Montenegro", no. 019/18) and the Decision on the announcement of the Tender for the conceptual - architectural design of the FC "Bokelj" Kotor stadium, no. 01-018/22-17694 from October 14, 2022, the members of the competition jury passed the following:

DECISION

On the extension of the deadline for the publication of the results of the Competition for the conceptual and architectural design of the stadium FC "Bokelj" Kotor

Article 1

The deadline for the publication of the results of the Competition for the conceptual and architectural design of the stadium FK "Bokelj" Kotor has been extended until March 31, 2023.

Article 2

All other conditions of the Contest remain in effect.

Article 3

This Decision enters into force on the day of publication on the website of the Municipality of Kotor.

Explanation

Based on the call for tenders for the conceptual and architectural design of the FC "Bokelj" Kotor stadium, ending at 00:00 (CET) on February 16, 2023, 63 tenders were received, which is according to the Rulebook on the manner and procedure of announcing and conducting a public tender for conceptual architectural solution noted by the reporter and the authorized person of the tenderer of the Competition in

the Minutes of February 17, 2023, after which the competition works without information about the authors were delivered to the jury members.

According to Article 35 paragraph 3 of the said Rulebook, during the review of the works, the jury decides which competitive works are considered for the awarding of prizes or purchases (short selection), that is, it evaluates and ranks the selected works.

Be aware of the complexity of the task and the large number of works received, the members of the jury, after reviewing the scope of the work, concluded that the time provided for reviewing and evaluating the works was insufficient. In order to pay due attention to each competition work and to select the best solutions, it was decided to postpone the deadline for notifying participants about the results of the competition, which according to the competition announcement was set for March 16, 2023, to March 31, 2023.
